The General Data Protection Regulation (GDPR) is a law that tells us how we must look after your personal information. We always follow the rules of GDPR.



The right to be informed

This means NDTi must give you information about how they are using your information.



The right of access

This means NDTi will let you have your information quickly if you ask for it.



The right to rectification

This means if NDTi hold information about you that is wrong, you have the right to have this corrected.



The right to erasure

This means you can ask NDTi to get rid of your information at any time.
