About the project & this privacy statement

Internships Work is a Department for Education (DfE) funded programme to increase the number and quality of supported internships (SIs) on offer for young people with a special educational need or disability (SEND). Internships Work is a consortium programme led by NDTi, with our partners DFN Project SEARCH and the British Association for Supported Employment; NDTi will also be supported by Family Fund.

There are different elements to NDTi's work involvement this project; this privacy statement covers the data that will be collected and processed during our activity to support Local Authorities (LAs) across England to establish and develop SEND employment forums.

Information you need to know

The National Development Team for Inclusion (NDTi) is a not-for-profit organisation working to enable people at risk of exclusion, due to age or disability, to live the life they choose. NDTi has been working with communities, government, health and social care professionals for 25 years to ensure that people with disabilities of all ages are given choice and control over their own lives. What information are we collecting?

The following personal data will be collected:

- LA Employment Lead name and/or other key contacts working on this project
- LA Employment Lead email address and/or other key contacts working on this project
- LA Employment Lead organisation and/or other key contacts working on this project
- Change stories (blogs, case studies, podcasts and videos containing personal stories about an intern or employer's experiences of SIs)
- LA baseline data (information about Sis and the local offer)
- Use of section 14 grant, including spend, activity and outcomes

Why are we collecting your data?

NDTi will collect and process data for the coordination and facilitation of support to LAs. Collecting and processing this data will ensure that NDTi can:

- support LAs to meet the requirements of the section 14 grant from the DfE, including the creation of an action plan and the development a SEND employment forum
- meet contractual obligations to the DfE in supporting LAs to achieve their action plans and targets related to the grant
- monitor use of the grant

How will we use this data?

Data will be used to coordinate, organise and facilitate support to LAs, including any sessions, events and meetings that are key to the delivery of this work. Information about LAs progress and use of the grant will be reported.

What is the lawful basis for processing the data?

NDTi has a **contractual obligation** to collect and process personal information for key contacts responsible for the spending of the LA section 14 grants in order for its use to be monitored and for support to be given to achieve the agreed outcomes.

If other LA colleagues wish to be contacted and kept up to date, then NDTi will seek their **consent**.

If we are sharing your data with others, who are we sharing it with?

NDTi will regularly report to the DfE about use and spend of the section 14 grant, including objectives and outcomes; however personal data will not be shared without the individual's consent.

How will we ensure your data is safe?

Your personal information will be stored electronically on NDTi's secure server. NDTi's systems are compliant with the official level of the Government Security Classifications Scheme. NDTi's systems also meet the requirements as outlined within the Cyber Essentials Scheme and are compliant with the General Data Protection Regulations (2018).

Access to the information will be restricted, and only members of the NDTi team working on the project will be able to access it. Where external systems are used to collect data (for example, Microsoft Forms), their privacy statements will be available to those sharing information.

Personal data will be deleted three months after the end of the project (March 2026).

What are your rights and how can you enforce them?

Your rights are detailed below. You can exercise your rights at any time, by making a request to NDTi's Data Protection Officer either verbally or in writing (contact details on page 1).

The right to be informed

We must provide you with information including: our purposes for processing your personal data, how long we intent to keep your personal data, and who, if anyone, we will share it with.

The right of access

NDTi have processes in place to ensure that we respond to a subject access request without undue delay and within one month of receipt.

The right to rectification

You have a right to have inaccurate personal data we hold about you rectified or completed if it is incomplete. We have one calendar month to respond to your request. In certain circumstances we can refuse a request for rectification.

How can you complain to the Information Commissioner's Office?

Whilst we encourage you to discuss any concerns you may have about how NDTi holds or processes your data with our Data Protection Officer, you have the right to complain directly to the Information Commissioner.
